As per Section 6 of the Waste Management Bylaw, a permit to place a non-conforming waste container in a residential area may be approved by administration on a case by case basis. Restrictions may be placed on the length of time a container may be in place, and on the type, size and placement of containers. The container may not negatively impact the safety, health, or welfare of the people in the neighbourhood or amenity of the neighbourhood. Permits may be issued for purposes such as construction, demolition, renovation, or Town authorized community wide clean-up events. All other purposes may be authorized at the discretion of Administration and may not generally include use for day-to-day household waste.
