Put the location it was signed (i.e. NAICAM), then the day (i.e. 12th) and month (i.e. September) of 2020

Candidate must have 2 witnesses witness them signing the form. Witnesses do not have to be eligible voters and they do not have to know the candidate. They can be anyone except the Town office staff who may not witness forms.
