

# Home Occupations

## Information Sheet

To facilitate economic development and foster entrepreneurship, many types of businesses can operate from a residence. The standards for home occupations are intended to seek a balance between a quiet, safe and aesthetic residential environment and the aspirations of home-based entrepreneurs. Business activities which may disturb neighbourhood peace are not permitted, as those must locate in an appropriate commercial or industrial zoning district.

## Application Process

There are two types of approvals required before operating a business out of your home.

1. A **Development Permit** allows business activities to be conducted from a residential property and is regulated by the Town of Naicam's Zoning Bylaw No. 3/85. Fee \$10 (one-time)
2. A **Business License** allows you to operate your business in the Town of Naicam and is authorized by Business License Bylaw No. 1-2016. Fee \$25 (annual)

The Home Occupation Application can be found on the Town's website or picked up at the Town Office.

Home occupations are discretionary in all residential districts within Naicam. This means that all applications require the approval of Council.

### Discretionary Use Process

1. Council is advised that an application has been made for a discretionary use.
2. At least 7 days prior to consideration by Council, public notice is provided to property owners within a 75 m radius of the proposed business location.
3. Council considers the application and holds a hearing.
4. The applicant is notified of Council's decision.

Upon approval of Council, the Notice of Decision is issued and, if approved, an application for a business license may be made and a license issued.

## Development Standards & Regulations

- Home occupations or home-based businesses may be accommodated provided they are an occupation, trade, profession or craft conducted entirely within a residential building and carried on by the inhabitants thereof, which use is clearly incidental and secondary to the residential use of the dwelling and does not change the exterior character.
- Home occupations shall be located in a dwelling unit (home). At this time this does not include garages or other accessory buildings.
- All business activities must be conducted entirely indoors.
- Home businesses must be operated by the resident or residents of the dwelling.
- Home occupations are permitted to have one permanent sign or notice not exceeding 1m<sup>2</sup> in area.
- Other than the single permitted sign, exterior display or storage of materials or variation from the residential character of the building are not permitted.

# Frequently Asked Questions

## **How long is a business license valid for?**

All business licenses are valid until December 31<sup>st</sup> of the year they are issued. Licenses are renewed annually. A renewal notice will be sent to the mailing address on your license in December.

## **Is there a fee?**

The business license fee for home occupations is \$25. The fee must accompany the application/renewal.

## **I am a renter. Do I need the property owner's permission?**

No. Obtaining permission to operate your business from the property owner is not required when making an application, but it is recommended.

## **What if I need to renovate or make alterations to my home to accommodate my home-based business?**

If structural alterations to your home are necessary to accommodate the business, a building permit is required. A building permit from the Town of Naicam is required prior to the start of construction. A business license will not be issued until the appropriate building permits have been taken out.

## **Is there anything else I should know about starting a business?**

There are many necessary steps in starting a business and meeting municipal requirements is just one those steps. For most businesses, there are provincial requirements for reserving a business name, registering a business entity, provincial sales tax, as well as federal requirements for goods and services tax. There may be other provincial and federal requirements depending on the nature of your business.

## **Where can I find out more about starting a business?**
